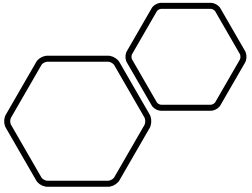

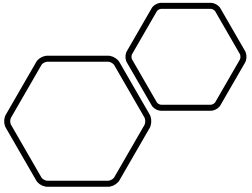

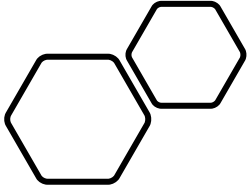

We will make sure that potential customers can find your aircraft. This presentation will be displayed on our own website and on several digital platforms like online marketplaces and social media.

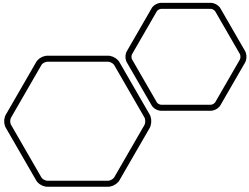

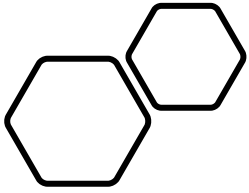

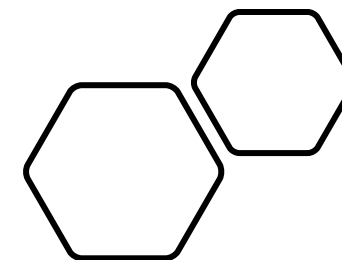
